Betreff : CORONAVIRUS COVID 19 GLOBAL IMPACTS – UPDATE 11

Dear Business Partner,

We want to make a step ahead and inform you about the current situation we face so far due to the Corona Virus GLOBALLY . Please notice that this statement is based on today knowledge and that this can change day by day due to goverments regulations from different countries

- AGAIN some global regions has major impacts due to COVID 19 , we see mainly in transport delay of shipments, major capacity problems at supply base and even Force Marjeure letters like TE. This situation is being foreseen by 01.2021 to be kepted under current conditions.
- CabTec has increased their capacities where possible, but due to training time etc shortterm demands within a 4-6 weeks timeframe mostly cannot be confirmed and will be rejected.
- CabTec reject all visits or Audit in all our European plants by end of 2020 and cannot currently not confirm any visit dates for 2021 due to unstable situation and travel restrictions by goverments again
- CabTec can confirm that our operations in China working well with no disruptions, BUT also here we see now impacts due to supply and capacity problems of European and NAFTA suppliers.
- CabTec has still temp controll and other hygienic actions applied in all our locations and this will be also kepted – under today view – by min end of Q 1 2021 in same way.
- CabTec RISK TEAM still check and coordinate detailed medical prevention and healthy actions on a daily base – this include also the right desinfection fluid for surfaces and employees
- Starting 20.10.2020 all EU office functions are back too Homeoffice, but on all workplaces which cannot be moved, special preventive actions has been taken to protect all employees
- CabTec has now first COVID 19 positive cases in his European location since 30.10.2020, we are in close contact with health departments from regional goverments to try to limit possible impacts to our productions sites and capacity. Any impacted customer will be informed by a special letter. The hygienic plan of all EU locations and the rules was updated to the higher level again , by the RISK TEAM by 01.11.2020 . Also CabTec will work to test all employees with possible symptoms by our own with fast result AntiGen Test shortterm by our own.
- **CabTec is proud to be still in the position to supply parts for ventilation systems , still needed in global locations, to fight against COVID 19. Also we are proud support with our own delevoped community mask the still ongoing situation for internal and external partners.**
